Fees and Agreement for HAPPY CHILD PRESCHOOL

Fees are due the 1st of the month, regardless of illness, vacation, or inclement weather. There will be a \$15.00 late fee for tuition paid after the 15th of the month. A \$20 fee will be charged for a returned check.

There is a discount option for annual tuition paid in full by September 15th: 7% off if paid by check; 4% off if paid by credit card. A \$10 per month tuition discount will be given for the second child in each family. Tuition paid is non-refundable. There are no discounts granted for inclement weather or other unforeseen circumstances, absences, or vacations. Total discounts will not exceed 10% per family per year.

A non-refundable \$50.00 registration fee is due with application (\$25.00 for second child). Your first month's tuition is due NO LATER than June 1st (this is September's tuition payment). Your next invoice will be sent October 1st. If you register your child after June 1st, the registration fee and the first month's tuition is due upon receipt of application.

**Please note Happy Child Preschool may assess a monthly snack fee (\$5-\$7/month) in response to our safety and health protocols during the pandemic. The decision on this snack fee will be made in August.*
